

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending the Plan of Operation for the Domestic Affairs Committee)

LEGISLATIVE ORDER NO. 23-008

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power to establish
2 rules and procedures to regulate all meetings of the Tohono O'odham Council,
3 standing committees, boards and special committees (Constitution of the
4 Tohono O'odham Nation, Article VI, Section 1(a)); and

5 **WHEREAS,** the Legislative Council adopted and amended the Legislative Rules of the Tohono
6 O'odham Legislative Council ("Legislative Rules") to govern the general structure
7 of the Council's standing committees; and

8 **WHEREAS,** Article XI, Section 2(C) of the Legislative Rules provides that "[t]he Rules
9 Committee shall review and make recommendations on proposed legislative
10 committee plans of operation and amendments to plans of operation to the
11 Legislative Council"; and

12 **WHEREAS,** the Plan of Operation for the Domestic Affairs Committee was adopted by
13 Legislative Order No. 01-431 and amended by Legislative Order Nos. 13-153 and
14 15-149; and

15 **WHEREAS,** the Domestic Affairs Committee has drafted an amendment to the Committee's
16 Plan of Operation to prohibit unauthorized recordings of Committee meetings
17 and manage closed meeting records; and

18 **WHEREAS,** the Rules Committee has reviewed and recommends adoption of the amended
19 Plan of Operation for the Domestic Affairs Committee as dated for reference
20 January 2023, which is incorporated by this reference.

21 **NOW, THEREFORE, BE IT ORDERED** that the Tohono O'odham Legislative Council adopts the
22 amended Plan of Operation for the Domestic Affairs Committee as dated for
23 reference January 2023, which will supersede and replace the Plan of Operation
24 adopted by Legislative Order No. 01-431 as amended by Legislative Order Nos. 13-
25 153 and 15-149.

26 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 09TH day of
27 JANUARY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-
28 AGAINST; [01] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
29 Article VI, Section 1(a) and (b) of the Constitution of the Tohono O'odham Nation, adopted by the
30 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
31 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
32 18, 1934 (48 Stat.984).
