9		of \$277,363.00 was approved by Resolution No. 22-136 in which the budget
10		authority expires on September 30, 2022; and
11	WHEREAS,	the Department of Health and Human Services has submitted for review and
12		approval its FY 2022 Administration for Children and Families Promotion Safe
13		and Stable Families Budget Extension, requesting to amend Resolution No. 22-
14		136 to extend the budget period through September 30, 2025 to allow for available
15		funds to be expended; and
16	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
17		reviewed and recommend approval of the FY 2022 Department of Health and
18		Human Services Administration for Children and Families Promotion Safe and
19		Stable Families Budget Extension through September 30, 2025.
20	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves an
21		extension of the budget authority for the FY 2022 Department of Health and
22		Human Services Administration for Children and Families Promotion Safe and

29		Tohono O'odham Legislative Council.
