

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 22-136, "Approving FY 2022 Department of Health and
Human Services Administration for Children and Families Promoting Safe and
Stable Families Budget" through FY 2025)**

RESOLUTION NO. 23-015

1 **WHEREAS,** the Tohono O'odham Legislative Council ("Council") is authorized "to manage any
2 funds within the exclusive control of the Tohono O'odham Nation . . . , and to
3 appropriate these funds for the benefits of the nation and its members" provided
4 that "(a)ll expenditures of these funds shall be pursuant to appropriations or
5 budgets" authorized by resolution or ordinance (Constitution of the Tohono
6 O'odham Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2022 Department of Health and Human Services Administration for
8 Children and Families Promoting Safe and Stable Families Budget in the amount
9 of \$277,363.00 was approved by Resolution No. 22-136 in which the budget
10 authority expires on September 30, 2022; and

11 **WHEREAS,** the Department of Health and Human Services has submitted for review and
12 approval its FY 2022 Administration for Children and Families Promotion Safe
13 and Stable Families Budget Extension, requesting to amend Resolution No. 22-
14 136 to extend the budget period through September 30, 2025 to allow for available
15 funds to be expended; and

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
17 reviewed and recommend approval of the FY 2022 Department of Health and
18 Human Services Administration for Children and Families Promotion Safe and
19 Stable Families Budget Extension through September 30, 2025.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves an
21 extension of the budget authority for the FY 2022 Department of Health and
22 Human Services Administration for Children and Families Promotion Safe and
23 Stable Families Budget in the amount of \$277,363.00 through September 30, 2025.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend FY 2022 Department of Health and Human Services Administration for
27 Children and Families Promotion Safe and Stable Families Budget, provided that
28 any amendments or modifications shall be submitted for prior approval by the
29 Tohono O'odham Legislative Council.
