

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2023 Tohono O'odham Nation Healthcare San Xavier Water
Main/Parking Lot Replacement Budget)

RESOLUTION NO. 23-018

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Health Care ("TONHC") has prepared and submitted**
8 **for review and approval its FY 2023 San Xavier Water Main/Parking Lot**
9 **Replacement Budget, which is incorporated by this reference, in the amount of**
10 **\$616,920.00 to be funded by the Indian Health Service ("IHS"); and**

11 **WHEREAS, IHS allows the use of funds until they have been fully expended, TONHC has**
12 **prepared the FY 2023 San Xavier Water Main/Parking Lot Replacement Budget to**
13 **expend funds for three years, effective October 1, 2022 through September 30,**
14 **2025; and**

15 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
16 **reviewed the FY TONHC 2023 San Xavier Water Main/Parking Lot Replacement**
17 **Budget and recommend approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2023 TONHC San Xavier Water Main/Parking Lot Replacement Budget in the**
20 **amount of \$616,920.00, effective October 1, 2022 through September 30, 2025,**
21 **which is funded by the Nation's general fund pending reimbursement by the**
22 **grantor, Indian Health Service.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2023 TONHC San Xavier Water Main/Parking Lot Replacement**
26 **Budget provided that any amendments or modifications shall be submitted for**
27 **prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**
29 **day of JANUARY, 2023 at a meeting at which a quorum was present with a vote of 2,947.3 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and 270.7 [06] ABSENT, pursuant to the powers vested in the Council**
31 **by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
32 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
33 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
34 **Act of June 18, 1934 (48 Stat.984).**


