

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 22-107 "Approving Tohono O'odham Nation Healthcare
FY 2022 American Rescue Plan Act Lost Reimbursement Budget" to extend
the Budget Authority into FY 2023)**

RESOLUTION NO. 23-019

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2) and (3)); and**

7 **WHEREAS, the FY 2022 Tohono O'odham Nation Healthcare American Rescue Plan Act Lost**
8 **Reimbursement Budget in the amount of \$19,034,930.00 was approved by**
9 **Resolution No. 22-107; and**

10 **WHEREAS, the Tohono O'odham Nation Health Care has submitted for review and approval**
11 **of its FY 2023 American Rescue Plan Act Lost Reimbursement Budget requesting**
12 **to amend Resolution No. 22-107 to extend the budget period into FY 2023 to allow**
13 **for available funds to be expended; and**

14 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
15 **reviewed the amending resolution and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves an**
17 **extension of the budget authority for FY 2023 Tohono O'odham Nation Healthcare**
18 **American Rescue Plan Act Lost Reimbursement Budget in the amount of**
19 **\$19,034,930.00 through September 30, 2023.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2023 Tohono O'odham Nation Healthcare American Rescue Plan**
23 **Act Lost Reimbursement Budget for the period of October 1, 2022 through**
24 **September 30, 2023 and the Accounting Office is authorized to post the**
25 **unexpended balances of the budget as of September 30, 2022 as a carryforward to**
26 **FY 2023 beginning October 1, 2022 provided that any amendments or**
27 **modifications shall be submitted for prior approval by the Tohono O'odham**
28 **Legislative Council.**






