1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the authority to "promote, protect and provide for public health, peace, morals,
3		education and general welfare of the Tohono O'odham Nation and its members"
4		and to "consult, negotiate and conclude agreements and contracts on behalf of
5		the Tohono O'odham Nation with Federal, State and local governments and other
6		Indian tribeswithin the authority of the Tohono O'odham Council."
7		(Constitution, Article VI, Section 1(c)(2) and Section 1(f)); and
8	WHEREAS,	the U.S. Department of Health and Human Services ("HHS") Secretary's Tribal
9		Advisory Committee ("STAC") was established in 2010 as the highest level tribal
10		advisory committee in the HHS, and is intended as a forum for government-to-
11		government consultation; and
12	WHEREAS,	the STAC's primary purpose is to identify issues and priorities, seek consensus,
13		exchange views, share information, provide advice and recommendations, and
14		coordinate with HHS agencies on all matters related to improving health and
15	7	human services and ensuring tribal consultation on HHS policies affecting
16	<u> </u>	American Indian and Alaska Native ("AI/AN") communities (STAC Charter); and
17	WHEREAS,	the STAC's tribal representation is comprised of seventeen positions filled by
18		voluntary representatives: one delegate (and one alternate) from each of the
19		twelve Indian Health Service ("IHS") areas and one delegate (and one alternate)
20		for five National At-Large Tribal Member positions; and
21	WHEREAS,	Representatives Daniel L. A. Preston, III and Evelyn Juan Manuel have served as
22		the STAC Tucson Area delegate and alternate; however, their terms expired
23		December 2022; and
24	WHEREAS,	the Health and Human Services Committee recommends the nominations of
25	,	Representatives Daniel L. A. Preston, III and Evelyn Juan Manuel to continue to
26		serve as STAC Tucson Area delegate and alternate.
27	NOW, THERI	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates
28		Representatives Daniel L. A. Preston, III and Evelyn Juan Manuel to serve as
29		Tucson Area delegate and alternate on the Secretary's Tribal Advisory
30		Committee.
