9		FY 2023 Professional Services Contract between the Tohono O'odham Nation and
10		Michael Brown, Esq., to represent clients who cannot be represented by the
11		Nation's Advocate Program due to a conflict of interest; and
12	WHEREAS,	the Domestic Affairs Committee has reviewed the contract and recommends
13		approval.
