The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono 8 O'odham Nation, and all expenditures of these funds shall be by checks 9 signed by such treasurer or other authorized officer and the chairman or 10 vice chairman of the district council. 11 ; and 12 WHEREAS. the FY 2023 Baboquivari District Administration and Community Budgets in the 13 amount of \$3,932,391.66 were authorized by Baboquivari District Council 14 Resolution No. 2022-B-73 and approved by Legislative Council Resolution No. 22-15 353 and subsequently amended by Resolution No. 22-395; and the FY 2018 and FY 2020 District Mining Royalties were approved respectively by 16 WHEREAS. 17 Legislative Council Resolution Nos. 18-143 and 20-240; and 18 WHEREAS. by Baboquivari District Council Resolution No. 2022-B-111, the Baboquivari 19 District Council has authorized the FY 2023 Baboquivari District Topawa 20 Community Budget, which is incorporated by this reference, in the amount of 21 \$24,362.44; and by Baboquivari District Council Resolution No. 2022-B-120, the Baboquivari 22 WHEREAS, District has authorized the FY 2023 Baboquivari District Cold Fields Community 23 Budget Amendment No. 1, which is incorporated by this reference and will adjust 24 operational and personnel line items, but will not change the original budget 25 26 amount of \$457,612.39; and the Budget and Finance Committee has reviewed the FY 2023 Baboquivari District 27 WHEREAS, Topawa Community Budget and FY 2023 Baboquivari District Cold Fields 28 Community Budget Amendment No. 1 and recommends approval. 29 30 31

- 2. the FY 2023 Baboquivari District Cold Fields Community Budget Amendment No. 1, effective October 1, 2022, which will not change the FY 2023 Cold Fields Community Budget of \$457,612.39.

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2023
Baboquivari District Administration and Community Budgets, as amended, shall
be managed and expended in accordance with Article IX, Section 7 of the
Constitution of the Tohono O'odham Nation and the Nation's laws, provided that
any amendments or modifications shall be authorized under District Council
resolution and submitted for prior approval by the Tohono O'odham Legislative
Council.
