RESOLUTION NO. 23-041

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**
2 **and ordinances governing the enrollment and adoption of members**
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**
6 **Enrollment Committee shall review membership applications and make a**
7 **written recommendation to the Tohono O'odham Legislative Council to approve**
8 **or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment**
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**
11 **O'odham Legislative Council shall determine eligibility for membership or**
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**
14 **name changes of enrolled members as a result of marriage, divorce, legal**
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Program recommends that Resolution Nos. 23-81, 49-81, 138-81,**
17 **95-82, 115-82, 127-83, 40-84, 12-88, 92-247, 95-319, 99-475, 2000-003, 2000-223, 01-**
18 **589, 09-167, 17-122 and 17-579 be amended to reflect the amended names for the**
19 **members identified in the February 2023 Amended Enrollment Resolution**
20 **Summary, which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
22 **Nos. 23-81, 49-81, 138-81, 95-82, 115-82, 127-83, 40-84, 12-88, 92-247, 95-319, 99-**
23 **475, 2000-003, 2000-223, 01-589, 09-167, 17-122 and 17-579 are amended upon the**
24 **effective date of those resolutions to reflect the legal name changes of members**
25 **identified in the February 2023 Amended Enrollment Resolution Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
27 **day of FEBRUARY, 2023 at a meeting at which a quorum was present with a vote of 2,730.7 FOR;**
28 **-0- AGAINST; -0- NOT VOTING; and 487.3[05] ABSENT, pursuant to the powers vested in the**
29 **Council by, Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the**
30 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**
31 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
32 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**






