07-657, 07-739, 08-005 and 22-387 to Correct Names and/or Enrollment  
Numbers of Enrolled Members)**

**RESOLUTION NO. 23-042**

1   **WHEREAS,**   the Tohono O'odham Legislative Council is vested with the power to enact laws  
2                   and ordinances governing the enrollment and adoption of members  
3                   (Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and  
4                   Article VI, Section 1(h)); and

5   **WHEREAS,**   pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the  
6                   Enrollment Committee shall review membership applications and make a  
7                   written recommendation to the Tohono O'odham Legislative Council to approve  
8                   or reject the application (14 Tohono O'odham Code Chapter 1 - Enrollment  
9                   Ordinance); and

10   **WHEREAS,**   pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono  
11                   O'odham Legislative Council shall determine eligibility for membership or  
12                   adoption; and

13   **WHEREAS,**   the Enrollment Program has determined that a number of resolutions approving  
14                   membership and adoption applications misspelled or incorrectly listed the  
15                   names of members and/or incorrectly listed enrollment numbers; and

16   **WHEREAS,**   the Enrollment Program recommends that Resolution Nos. 97-350, 98-083, 04-  
17                   659, 05-204, 05-607, 07-657, 07-739, 08-005 and 22-387 be amended to reflect the  
18                   correct names and/or enrollment numbers for the members identified in the  
19                   February 2023 Corrected Enrollment Resolution Summary, which is  
20                   incorporated by this reference.

21   **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
22                   Nos. 97-350, 98-083, 04-659, 05-204, 05-607, 07-657, 07-739, 08-005 and 22-387 are  
23                   amended upon the effective date of those resolutions to reflect the correct names  
24                   and/or enrolment numbers of members identified in the February 2023  
25                   Corrected Enrollment Resolution Summary.

26   **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>**  
27   **day of FEBRUARY, 2023 at a meeting at which a quorum was present with a vote of 2,730.7 FOR;**  
28   **-0- AGAINST; -0- NOT VOTING; and 487.3[05] ABSENT, pursuant to the powers vested in the**  
29   **Council by, Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the**  
30   **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**  
31   **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**  
32   **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
