

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Law Enforcement Mutual Aid Agreement Between the Tohono O'odham Nation and Maricopa County)

RESOLUTION NO. 23-048

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "consult,**
2 **negotiate and conclude agreements . . . on behalf of the Tohono O'odham Nation**
3 **with Federal, State and local governments . . . or their departments, agencies, or**
4 **political subdivisions . . . on all matters within the authority of the Tohono**
5 **O'odham Council" and to "promote, protect and provide for public health, peace,**
6 **morals, education and general welfare of the Tohono O'odham Nation and its**
7 **members" (Constitution of the Tohono O'odham Nation, Article VI, Section 1(f)**
8 **and Article VI, Section 1(c)(2)); and**

9 **WHEREAS, the Tohono O'odham Nation entered into a Mutual Protection and Law**
10 **Enforcement Agreement with Maricopa County approved by Resolution No. 14-**
11 **559; and**

12 **WHEREAS, the Tohono O'odham Nation has negotiated a new Law Enforcement Mutual Aid**
13 **Agreement Between the Tohono O'odham Nation and Maricopa County to provide**
14 **mutual aid and assistance in the field of law enforcement; and**

15 **WHEREAS, the Domestic Affairs Committee has reviewed the Law Enforcement Mutual Aid**
16 **Agreement Between the Tohono O'odham Nation and Maricopa County and**
17 **recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **Law Enforcement Mutual Aid Agreement Between the Tohono O'odham Nation**
20 **and Maricopa County.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation chairperson or any designated official is authorized to execute the Law**
23 **Enforcement Mutual Aid Agreement Between the Tohono O'odham Nation and**
24 **Maricopa County substantially in the form attached hereto provided that any**
25 **amendments shall be submitted for prior approval by the Tohono O'odham**
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
28 **day of FEBRUARY, 2023 at a meeting at which a quorum was present with a vote of 2,052.3 FOR;**
29 **678.4 AGAINST; [01] NOT VOTING; and 487.3[04] ABSENT, pursuant to the powers vested in the**
30 **Council by, Article VI, Sections 1(c)(2) and (f) of the Constitution of the Tohono O'odham Nation,**
31 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
32 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
33 **Act of June 18, 1934 (48 Stat.984).**






