12		by Resolution No. 14-224 which has expired; and
13	WHEREAS,	the Tohono O'odham Nation has negotiated a new Law Enforcement Mutual Aid
14		Agreement Between the Tohono O'odham Nation and the Town of Florence to
15		provide mutual aid and assistance in the field of law enforcement; and
16	WHEREAS,	the Domestic Affairs Committee has reviewed the Law Enforcement Mutual Aid
17		Agreement Between the Tohono O'odham Nation and the Town of Florence and
18		recommends its approval.
19	NOW, THERI	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
20		Law Enforcement Mutual Aid Agreement Between the Tohono O'odham Nation
21		and the Town of Florence.
