

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Law Enforcement Mutual Aid Agreement Between the Tohono
O'odham Nation and the Town of Florence)**

RESOLUTION NO. 23-049

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "consult,**
2 **negotiate and conclude agreements . . . on behalf of the Tohono O'odham Nation**
3 **with Federal, State and local governments . . . or their departments, agencies, or**
4 **political subdivisions . . . on all matters within the authority of the Tohono**
5 **O'odham Council" and to "promote, protect and provide for public health, peace,**
6 **morals, education and general welfare of the Tohono O'odham Nation and its**
7 **members" (Constitution of the Tohono O'odham Nation, Article VI, Section 1(f)**
8 **and Article VI, Section 1(c)(2); and**

9 **WHEREAS, the Tohono O'odham Nation entered into a Mutual Protection Agreement**
10 **approved by Resolution No. 08-600; and**

11 **WHEREAS, the Tohono O'odham Nation renewed the Mutual Protection Agreement approved**
12 **by Resolution No. 14-224 which has expired; and**

13 **WHEREAS, the Tohono O'odham Nation has negotiated a new Law Enforcement Mutual Aid**
14 **Agreement Between the Tohono O'odham Nation and the Town of Florence to**
15 **provide mutual aid and assistance in the field of law enforcement; and**

16 **WHEREAS, the Domestic Affairs Committee has reviewed the Law Enforcement Mutual Aid**
17 **Agreement Between the Tohono O'odham Nation and the Town of Florence and**
18 **recommends its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **Law Enforcement Mutual Aid Agreement Between the Tohono O'odham Nation**
21 **and the Town of Florence.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to execute the Law**
24 **Enforcement Mutual Aid Agreement Between the Tohono O'odham Nation and**
25 **the Town of Florence substantially in the form attached hereto provided that any**
26 **amendments shall be submitted for prior approval by the Tohono O'odham**
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
29 **day of FEBRUARY, 2023 at a meeting at which a quorum was present with a vote of 2,539.6 FOR;**
30 **121.9 AGAINST; 556.5[02] NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**
31 **Council by, Article VI, Sections 1(c)(2) and (f) of the Constitution of the Tohono O'odham Nation,**
32 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
33 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
34 **Act of June 18, 1934 (48 Stat.984).**


