

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Treena Parvello to the Board of Trustees for
the Tohono O'odham Community College)**

RESOLUTION NO. 23-050

1 **WHEREAS,** the Legislative Council is vested with the power to “provide for, appoint, or
2 provide for the appointment of, and prescribe the duties and powers of
3 committees, boards, officers and agents” and “to promote, protect and provide
4 for public health, peace, morals, education and general welfare of the Tohono
5 O’odham Nation and its members” (Constitution, Article VI, Section 1(b) and
6 Section 1(c)(2)); and

7 **WHEREAS,** by Resolution No. 98-006, the Legislative Council enacted and subsequently
8 amended the Charter of the Tohono O’odham Community College (“TOCC”),
9 codified as 11 Tohono O’odham Code Chapter 1, which authorizes the Board of
10 Trustees (“Trustees”) to operate a college to serve as the Tohono O’odham
11 Nation’s center for higher education, research, culture and tradition, with
12 authority to grant post-secondary degrees and certificates (11 Tohono O’odham
13 Code Chapter 1, Article III(A)); and

14 **WHEREAS,** the TOCC Charter provides that the Board of Trustees “shall be appointed by the
15 Chairperson of the Nation with the approval of the Legislative Council” and shall
16 serve terms of four years or until their successors are appointed and qualified (11
17 Tohono O’odham Code Chapter 1, Article V(C) and Article V(F)); and

18 **WHEREAS,** the Nation’s Chairman Ned Norris, Jr. has appointed Treena Parvello to the
19 Tohono O’odham Community College Board of Trustees, subject to Legislative
20 Council approval; and

21 **WHEREAS,** the Human Resources Development and Rules Committees have reviewed the
22 Chairman’s appointment and recommend approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O’odham Legislative Council approves the
24 appointment of Treena Parvello to the Tohono O’odham Community College
25 Board of Trustees for a term beginning on the effective date of this resolution and
26 expiring on February 20, 2027, provided that she shall continue to serve until her
27 successor has been appointed and qualified.

28 **The foregoing Resolution was passed by the Tohono O’odham Legislative Council on the 13TH**
29 **day of FEBRUARY, 2023 at a meeting at which a quorum was present with a vote of 3,001.4 FOR; -**
30 **0- AGAINST; [01] NOT VOTING; and 216.6 [03] ABSENT, pursuant to the powers vested in the**
31 **Council by, Article VI, Section 1(h) and Section 1(c)(2) of the Constitution of the Tohono O’odham**
32 **Nation, adopted by the Tohono O’odham Nation on January 18, 1986; and approved by the Acting**
33 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
34 **16 of the Act of June 18, 1934 (48 Stat.984).**


