

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Gu-Vo District Kukatch Community Budget Amendment No.1)**

**RESOLUTION NO. 23-055**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

11 ; and

12 **WHEREAS,** the FY 2023 Gu-Vo District Budget in the amount of \$5,055,834.82 was authorized  
13 by Gu-Vo District Council Resolution No. GV-22-061 and approved by Legislative  
14 Council Resolution No. 22-359; and

15 **WHEREAS,** by Gu-Vo District Council Resolution No. GV-23-002, the Gu-Vo District has  
16 authorized and submitted for review and approval its FY 2023 Kukatch  
17 Community Budget Amendment No. 1, which is incorporated by this reference  
18 and which will adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2023 Gu-Vo District Kukatch Community Budget Amendment No. 1 will  
20 increase the FY 2023 Gu-Vo District Kukatch Community Budget by \$228,875.30  
21 from \$393,239.17 to \$622,114.47.

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 Gu-Vo District  
23 Kukatch Community Budget Amendment No. 1 and recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
25 FY 2023 Gu-Vo District Kukatch Community Budget Amendment No. 1 effective  
26 October 1, 2022, which includes a \$228,875.30 increase from \$393,239.17 to  
27 \$622,114.47 that shall be funded by Kukatch Community Budgets carry forward  
28 balances as follows:

- 29 1. FY 2015 carry forward funds in the amount of \$91,210.30;
- 30 2. FY 2016 carry forward funds in the amount of \$30,049.76; and
- 31 3. FY 2017 carry forward funds in the amount of \$107,615.24.

32 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2023 Gu-Vo  
33 District Budget as amended shall be managed and expended in accordance with



1 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the  
2 Nation's laws, provided that any amendments or modifications shall be  
3 authorized under District Council resolution and submitted for prior approval by  
4 the Tohono O'odham Legislative Council.

5 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>  
6 day of FEBRUARY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR;  
7 -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,  
8 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
9 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
10 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934  
11 (48 Stat.984).




