

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Judicial Branch Budget Amendment No. 1)**

RESOLUTION NO. 23-056

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2023 Judicial Branch Budget in the amount of \$7,948,077.98 was approved**
8 **by Resolution No. 22-267; and**

9 **WHEREAS, the Judicial Branch has prepared and submitted for review and approval its FY**
10 **2023 Judicial Branch Budget Amendment No. 1, which is incorporated by this**
11 **reference and which will adjust personnel, operational, and/or capital line items;**
12 **and**

13 **WHEREAS, the FY 2023 Judicial Branch Budget Amendment No. 1 will not change the budget**
14 **amount of \$7,948,077.98; and**

15 **WHEREAS, the Judiciary and Budget and Finance Committees have reviewed the FY 2023**
16 **Judicial Branch Budget Amendment No. 1 and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2023 Judicial Branch Budget Amendment No. 1 effective October 1, 2022, which**
19 **will not change the budget amount of \$7,948,077.98.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chief judge or any designated official is authorized to administer and**
22 **expend the FY 2023 Judicial Branch Budget as amended, provided that any**
23 **modifications or amendments shall be submitted for prior approval by the**
24 **Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
26 **day of FEBRUARY, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -**
27 **0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by,**
28 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**
