

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving a No Cost Extension for the FY 2023 Department of Health and Human Services Division of Community Health Services Haury Grant Project Budget)**

**RESOLUTION NO. 23-064**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation... and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2023 Department of Health and Human Services Division of Community**  
8 **Health Services Haury Grant Project Budget in the amount of \$9,728.65 was**  
9 **approved by Resolution No. 22-307; and**

10 **WHEREAS, the Department of Health and Humans Services Division of Community Health**  
11 **Services has received a no cost extension notice from the Agnese N. Haury**  
12 **Program in Environmental and Social Justice to extend the Haury Grant Project**  
13 **Budget until June 30, 2023; and**

14 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
15 **reviewed the FY 2023 Department of Health and Human Services Division of**  
16 **Community Health Services Haury Grant Project Budget and recommends its**  
17 **approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **no cost extension of the FY 2023 Department of Health and Human Services**  
20 **Division of Community Health Services Haury Grant Project Budget to June 30,**  
21 **2023.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
23 **Nation chairperson or any designated official is authorized to administer and**  
24 **expend the FY 2023 Department of Health and Human Services Division of**  
25 **Community Health Services Haury Grant Project Budget as amended, provided**  
26 **that any amendments or modifications shall be submitted for prior approval by**  
27 **the Tohono O'odham Legislative Council.**


28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup>**

31 **Article VI Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat.984).**


