

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**

**RESOLUTION NO. 23-073**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members**  
3 **(Constitution of the Tohono O'odham Nation, Article II, Sections 1 and 2 and**  
4 **Article VI, Section 1(h)); and**

5 **WHEREAS, pursuant to Article VI and VII of the Nation's Enrollment Ordinance, the**  
6 **Enrollment Committee shall review membership applications and make a**  
7 **written recommendation to the Tohono O'odham Legislative Council to approve**  
8 **or reject the application (14 Tohono O'odham Code Chapter 1 – Enrollment**  
9 **Ordinance); and**

10 **WHEREAS, pursuant to Article VIII of the Nation's Enrollment Ordinance, the Tohono**  
11 **O'odham Legislative Council shall determine eligibility for membership or**  
12 **adoption; and**

13 **WHEREAS, the Enrollment Program has received official documents reflecting the legal**  
14 **name changes of enrolled members as a result of marriage, divorce, legal**  
15 **adoption, or for other reasons; and**

16 **WHEREAS, the Enrollment Committee recommends that Resolution Nos. 15-80, 32-80, 74-81,**  
17 **138-81, 115-82, 122-82, 09-85, 33-87, 436-87, 303-88, 95-366, 95-415, 96-514, 98-083,**  
18 **99-039, 2000-486, 02-180, 09-575, 14-465, and 18-098 be amended to reflect the**  
19 **amended names for the members identified in the March 2023 Amended**  
20 **Enrollment Resolution Summary, which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
22 **Nos. 15-80, 32-80, 74-81, 138-81, 115-82, 122-82, 09-85, 33-87, 436-87, 303-88,**  
23 **95-366, 95-415, 96-514, 98-083, 99-039, 2000-486, 02-180, 09 575, 14-465, and 18-098**  
24 **are amended upon the effective date of those resolutions to reflect the legal name**  
25 **changes of members identified in the March 2023 Amended Enrollment**  
26 **Resolution Summary.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
28 **day of MARCH, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**  
30 **Article II, Sections 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono O'odham**  
31 **Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
32 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
33 **16 of the Act of June 18, 1934 (48 Stat.984).**


