

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Accepting the Arizona Department of Education, Health and Nutrition Services Child and Adult Care Food Program Emergency Operational Costs Reimbursement Program Funds and Approving FY 2023 Department of Education, Division of Early Childhood Child and Adult Care Food Program Emergency Operational Cost Reimbursement Budget)**

**RESOLUTION NO. 23-076**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Arizona Department of Education ("ADE"), Health and Nutrition Services  
8 ("HNS") has granted additional funds, the Child and Adult Care Food Program  
9 ("CACFP") Emergency Operational Costs Reimbursement Program Funds to the  
10 Tohono O'odham Nation ("Nation"), Division of Early Childhood Development, as  
11 a participant in the CACFP; and

12 **WHEREAS,** the Department of Education has prepared and submitted for review and  
13 approval its FY 2023 Division of Early Childhood Development CACFP Emergency  
14 Operational Cost Reimbursement Budget, which is incorporated by this  
15 reference, in the amount of \$11,319.22 to be funded by the Nation's general fund  
16 pending reimbursement from the ADE, HNS; and

17 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have  
18 reviewed the FY 2023 Department of Education Division of Early Childhood  
19 Development CACFP Emergency Operational Cost Reimbursement Budget and  
20 recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts the  
22 ADE, HNS CACFP Emergency Operational Costs Reimbursement Program funds  
23 and approves the FY 2023 Department of Education Division of Early Childhood  
24 Development CACFP Emergency Operational Cost Reimbursement Budget  
25 effective October 1, 2022, in amount of \$11,319.22, which shall be funded by the  
26 Nation's general fund pending reimbursement from the ADE.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
28 Nation chairperson or any designated official is authorized to administer and  
29 expend the FY 2023 Department of Education Division of Early Childhood  
30 Development CACFP Emergency Operational Cost Reimbursement Budget,


