10	WHEREAS,	during fiscal years 2017, 2018, 2019, 2020 and 2021 Hewel Ni'ok received
11		underwriting and service revenues totaling \$38,781.36 which remain
12		unobligated; and
13	WHEREAS,	Hewel Ni'ok has prepared and submitted for review and approval its FY 2023
14		Hewel Ni'ok Revenue Budget, which is incorporated by this reference, in the
15		amount of \$38,781.36 to be funded from the Revenue Account; and
16	WHEREAS,	the Cultural Preservation and the Budget and Finance Committees have reviewed
17		the FY 2023 Hewel Ni'ok Revenue Budget and recommend its approval.
18	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
19	,	FY 2023 Hewel Ni'ok Revenue Budget effective October 1, 2022, in the amount of
20		\$38,781.36 which shall be funded from the Revenue Account of Hewel Ni'ok.
