6		Section 1(c)(2) and Section 1(j)); and
7	WHEREAS,	in 2005, the Centers for Disease Control and Prevention/Agency for Toxic
8		Substances and Disease Registry ("CDC/ATSDR") established the Tribal Advisory
9	.	Committee ("TAC"), which serves as an advisory committee to CDC/ATSDR
10		providing input, guidance, and advice on policies, guidelines, and programmatic
11		issues affecting the health of American Indian/Alaska Native tribes; and
12	WHEREAS,	the TAC is comprised of 17 delegates who are elected tribal officials or designated
13	i	representatives acting in their official capacities: one delegate (and one
14		designated alternate in the delegate's absence) from each of the 12 Indian Health
15		Service ("IHS") areas and five delegates (and five designated alternates) from
16		National At-Large Tribal Member positions; and
17	WHEREAS,	the Health and Human Services Committee recommends the nomination of
18		Representative Delma M. Garcia for appointment as delegate from the Tucson
19		Area on the CDC/ATSDR TAC and Representative Evelyn Juan Manuel as alternate.
20	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates
21		Representative Delma M. Garcia for appointment as delegate from the Tucson
22		Area on the Centers for Disease Control and Prevention/Agency for Toxic
23		Substances and Disease Registry Tribal Advisory Committee and Representative
24		Evelyn Juan Manuel as alternate.
