6		Section 1(c)(2) and Section 1(j)); and
7	WHEREAS,	the National Indian Health Board ("NIHB"), established in 1972, serves all
8		Federally recognized American Indian and Alaska Native tribal governments by
9		advocating for the improvement of health care delivery to American Indians and
10		Alaska Natives; and
11	WHEREAS,	the NIHB is governed by a Board of Directors consisting of representatives elected
12		by the American Indian and Alaska Native tribal governments in each of the 12
13		Indian Health Service ("IHS") areas; and
14	WHEREAS,	the NIHB has designated the Nation as a member of the Tucson Area and the
15		Nation has previously appointed representatives and alternates to the NIHB; and
16	WHEREAS,	the Health and Human Services Committee recommends the nomination of
17		Representative Delma M. Garcia for appointment as the Tucson Area
18		representative on the NIHB and Representative Daniel L.A. Preston, III as
19		alternate.
20	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates
21		Representative Delma M. Garcia for appointment as the Tucson Area
22		representative on the National Indian Health Board and Representative Daniel
23		I.A. Preston, III as alternate.
