

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Representative Delma M. Garcia as the Tucson Area Representative on the National Indian Health Board and Representative Daniel L.A. Preston, III as Alternate)

RESOLUTION NO. 23-082

1 **WHEREAS,** the Tohono O'odham Legislative Council is vested with the power "to promote,
2 protect and provide for public health . . . and general welfare of the Tohono
3 O'odham Nation and its members" and with the authority "to consult with the
4 Congress of the United States and appropriate federal agencies regarding federal
5 activities that affect the Tohono O'odham Nation" (Constitution, Article VI,
6 Section 1(c)(2) and Section 1(j)); and

7 **WHEREAS,** the National Indian Health Board ("NIHB"), established in 1972, serves all
8 Federally recognized American Indian and Alaska Native tribal governments by
9 advocating for the improvement of health care delivery to American Indians and
10 Alaska Natives; and

11 **WHEREAS,** the NIHB is governed by a Board of Directors consisting of representatives elected
12 by the American Indian and Alaska Native tribal governments in each of the 12
13 Indian Health Service ("IHS") areas; and

14 **WHEREAS,** the NIHB has designated the Nation as a member of the Tucson Area and the
15 Nation has previously appointed representatives and alternates to the NIHB; and

16 **WHEREAS,** the Health and Human Services Committee recommends the nomination of
17 Representative Delma M. Garcia for appointment as the Tucson Area
18 representative on the NIHB and Representative Daniel L.A. Preston, III as
19 alternate.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council nominates
21 Representative Delma M. Garcia for appointment as the Tucson Area
22 representative on the National Indian Health Board and Representative Daniel
23 L.A. Preston, III as alternate.

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that an appointment
25 made pursuant to this resolution shall immediately expire if the appointed
26 representative no longer serves on the Health and Human Services Committee for
27 any reason.

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
29 **day of MARCH, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by,**
31 **Article VI, Section 1(c)(2), and Section 1(j) of the Constitution of the Tohono O'odham Nation,**
32 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
33 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
34 **Act of June 18, 1934 (48 Stat.984).**




