

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Department of Health and Human Services Family Violence
Prevention Services American Rescue Act Plan COVID-19 Grant Budget)

RESOLUTION NO. 23-084

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2023 Family Violence Prevention Services American
9 Rescue Act Plan COVID-19 Grant Budget, which is incorporated by this reference,
10 in the amount of \$1,948,318.00 to be funded by the Nation's general fund pending
11 reimbursement from the grantor, the U.S. Department of Health and Human
12 Services; and

13 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
14 reviewed the FY 2023 Department of Health and Human Services Family Violence
15 Prevention Services American Rescue Act Plan COVID-19 Grant Budget and
16 recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 **FY 2023 Department of Health and Human Services Family Violence Prevention**
19 **Services American Rescue Act Plan Grant Budget effective October 1, 2022**
20 **through September 30, 2025, in the amount of \$1,948,318.00, which shall be**
21 **funded by the Nation's general fund pending reimbursement from the grantor,**
22 **the U.S. Department of Health and Human Services.**

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend these funds for the period of October 1, 2022 through September 30, 2025,**
26 **and the Accounting Department is authorized to post the unexpended balance of**
27 **the budget, provided that any amendments or modifications shall be submitted**
28 **for prior approval by the Tohono O'odham Legislative Council.**
