

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Schuk Toak District Queens Well Community
Budget Amendment No. 1)**

RESOLUTION NO. 23-087

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only
6 by a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2023 Schuk Toak District Budget in the amount of \$3,932,391.66 was
13 authorized by Schuk Toak District Council Resolution No. ST-08-29-22-085 and
14 approved by Legislative Council Resolution No. 22-355; and

15 **WHEREAS,** by the Schuk Toak District Council Resolution No. ST-02-11-23-020, the Schuk
16 Toak District has authorized and submitted for review and approval its FY 2023
17 Queens Well Community Budget Amendment No. 1, which is incorporated by this
18 reference and which will adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2023 Schuk Toak District Queens Well Community Budget Amendment No.
20 1 will not change the FY 2023 Schuk Toak District Queens Well Community Budget
21 amount of \$85,000.00; and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 Schuk Toak District
23 Queens Well Community Budget Amendment No. 1 and recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
25 FY 2023 Schuk Toak District Queens Well Community Budget Amendment No. 1
26 effective October 1, 2022, which will not change the FY 2023 Schuk Toak District
27 Queens Well Community Budget amount of \$85,000.00 nor the FY 2023 Schuk
28 Toak District Budget amount of \$3,932,391.66.


29 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2023 Schuk


authorized under District Council resolution and submitted for prior approval by


