13		T.O.C. Chapter 1, Article 2, Section 1203); and
14	WHEREAS,	the term of a pro tempore judge "shall be set forth in the resolution of the
15	, in the same of	Legislative Council appointing the judge, but in no case shall the term be longer
16		than six years" (6 T.O.C. Chapter 1, Article 2, Section 1204); and
17	WHEREAS,	the chief judge has submitted Tessa L. Dysart's resume, letter of interest, and a
