

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Department of Health and Human Services  
CDC Health Disparities Budget)**

**RESOLUTION NO. 23-109**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
8 **review and approval its FY 2023 CDC Health Disparities Budget, which is**  
9 **incorporated by this reference, in the amount of \$199,998.00 to be funded by the**  
10 **Nation's General Fund pending reimbursement from the Pima County Health**  
11 **Department CDC Health Disparities Grant; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
13 **reviewed the FY 2023 Department of Health and Human Services CDC Health**  
14 **Disparities Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
16 **FY 2023 Department of Health and Human Services CDC Health Disparities**  
17 **Budget in the amount of \$199,998.00 effective January 18, 2022 through May 31,**  
18 **2024, which shall be funded by the Nation's General Fund pending**  
19 **reimbursement from the Pima County Health Department CDC Health**  
20 **Disparities Grant.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation chairperson or any designated official is authorized to administer and**  
23 **expend the FY 2023 Department of Health and Human Services CDC Health**  
24 **Disparities Budget, provided that any amendments or modifications shall be**  
25 **submitted for prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>**  
27 **day of APRIL, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**  
28 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**  
29 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat.984).**
