

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Resolution No. 22-107 "Approving Tohono O'odham Nation Healthcare  
FY 2022 American Rescue Plan Act Lost Reimbursement Budget"  
to extend the Budget Authority into FY 2023)**

**RESOLUTION NO. 23-113**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2) and (3)); and

7 **WHEREAS,** the FY 2022 Tohono O'odham Nation Healthcare American Rescue Plan Act Lost  
8 Reimbursement Budget in the amount of \$19,034,930.00 was approved by  
9 Resolution No. 22-107; and

10 **WHEREAS,** Tohono O'odham Nation Health Care is requesting the budget term be extended  
11 for the FY 2022 American Rescue Plan Act Lost Reimbursement Budget in amount  
12 of \$19,034,930.00, which expired on September 30, 2022, into FY 2023 to expend  
13 available funds; and

14 **WHEREAS,** Tohono O'odham Nation Health Care with the amendment will also be creating  
15 two new line items, 7210 Dues and Subscriptions and 7400 RM Equipment; and

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
17 reviewed the FY 2022 American Rescue Plan Act Lost Reimbursement Budget  
18 amending resolution and recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council amends  
20 Resolution No. 22-107 to extend the budget authority for the FY 2022 Tohono  
21 O'odham Nation Healthcare American Rescue Plan Act Lost Reimbursement  
22 Budget in the amount of \$19,034,930.00 effective October 1, 2021 ending  
23 September 30, 2023.

24 **BE IT FURTHER RESOLVED** approves the creating of two new line items, 7210 Dues and  
25 Subscriptions and 7400 RM Equipment.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
27 Nation chairperson or any designated official is authorized to administer and  
28 expend the FY 2022 Tohono O'odham Nation Healthcare American Rescue Plan  
29 Act Lost Reimbursement Budget as amended, provided that any amendments or  
30 modifications shall be submitted for prior approval by the Tohono O'odham  
31 Legislative Council.


