

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023 Sells District Administration Budget Amendment No. 1 and  
Ge Oidag Community Budget Amendment No. 1)**

**RESOLUTION NO. 23-116**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to  
4 budgets authorized under resolutions of the district council and  
5 approved by the Tohono O'odham Council. The management of  
6 these funds shall be only by a treasurer or other authorized officer  
7 of the district council who has furnished a surety bond satisfactory  
8 to the treasurer of the Tohono O'odham Nation, and all  
9 expenditures of these funds shall be by checks signed by such  
10 treasurer or other authorized officer and the chairman or vice  
11 chairman of the district council.

13 **WHEREAS,** the FY 2023 Sells District Gaming Revenue Budgets in the amount of \$4,500,000.00  
14 was authorized by Sells District Council Resolution No. SD-78-22 and approved by  
15 Legislative Council Resolution No. 22-338; and

16 **WHEREAS,** the FY 2023 Sells District Gaming Revenue Budgets included the FY 2023 Sells  
17 District Administration Budget in the amount of \$3,975,000.00 and the FY 2023  
18 Sells District Ge Oidag Community Budget in the amount of \$120,000.00; and

19 **WHEREAS,** by Sells District Council Resolution No. SD-46-23, the Sells District has authorized  
20 and submitted for review and approval its FY 2023 Sells District Administration  
21 Budget Amendment No. 1, which is incorporated by this reference and which will  
22 adjust operational and/or personnel line items, but will not change the original  
23 budget amount of \$3,975,000.00; and

24 **WHEREAS,** by Sells District Council Resolution No. SD-52-23, the Sells District has authorized  
25 and submitted for review and approval its FY 2023 Sells District Ge Oidag  
26 Community Budget Amendment No. 1, which is incorporated by this reference  
27 and which will adjust operational and/or personnel line items, but will not  
28 change the original budget amount of \$120,000.00; and

29 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 Sells District  
30 Administration Budget Amendment No. 1 and the FY 2023 Sells District Ge Oidag  
31 Community Budget Amendment No. 1 and recommends approval.


**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves:**

- 1. the FY 2023 Sells District Administration Budget Amendment No. 1 effective October 1, 2022, which will not change the FY 2023 Sells District Administration Budget amount of \$3,975,000.00; and**
- 2. the FY 2023 Sells District Ge Oidag Community Budget Amendment No. 1, which will not change the FY 2023 Sells District Ge Oidag Community Budget amount of \$120,000.00.**

**BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2023 Sells District Gaming Revenue Budgets as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.**

**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> day of APRIL, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by, Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
