District Administration Budget in the amount of \$3,975.000.00 and the FY 2023 17 Sells District Ge Oidag Community Budget in the amount of \$120,000.00; and 18 by Sells District Council Resolution No. SD-46-23, the Sells District has authorized 19 WHEREAS. and submitted for review and approval its FY 2023 Sells District Administration 20 Budget Amendment No. 1, which is incorporated by this reference and which will 21 adjust operational and/or personnel line items, but will not change the original 22 budget amount of \$3,975,000.00; and 23 by Sells District Council Resolution No. SD-52-23, the Sells District has authorized 24 WHEREAS. and submitted for review and approval its FY 2023 Sclls District Ge Oidag 25 Community Budget Amendment No. 1, which is incorporated by this reference 26 and which will adjust operational and/or personnel line items, but will not 27 change the original budget amount of \$120,000.00; and 28 the Budget and Finance Committee has reviewed the FY 2023 Sells District 29 WHEREAS.
