

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2022 Sells District North Communities Multi-Year Budget  
Amendment No. 1)**

**RESOLUTION NO. 23-118**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3                   **No district council shall expend district funds except pursuant to**  
4                   **budgets authorized under resolutions of the district council and**  
5                   **approved by the Tohono O'odham Council. The management of**  
6                   **these funds shall be only by a treasurer or other authorized officer**  
7                   **of the district council who has furnished a surety bond satisfactory**  
8                   **to the treasurer of the Tohono O'odham Nation, and all**  
9                   **expenditures of these funds shall be by checks signed by such**  
10                   **treasurer or other authorized officer and the chairman or vice**  
11                   **chairman of the district council.**

13 **WHEREAS,** the FY 2020 Sells District North Communities Multi-Year Budget in the amount of  
14 \$1,225,000.00 was approved by Legislative Council Resolution No. 20-079; and

15 **WHEREAS,** the FY 2021 Sells District North Communities Multi-Year Budget in the amount of  
16 \$1,133,620.59 was approved by Legislative Council Resolution No. 21-008; and

17 **WHEREAS,** the FY 2022 Sells District North Communities Multi-Year Budget effective October  
18 1, 2021 through September 30, 2024 in the amount of \$870,848.15 was authorized  
19 by Sells District Council Resolution No. SD-17-22 and approved by Legislative  
20 Council Resolution No. 22-103; and

21 **WHEREAS,** by Sells District Council Resolution No. SD-48-23, the Sells District has authorized  
22 and submitted for review and approval its FY 2022 Sells District North  
23 Communities Multi-Year Budget Amendment No. 1, which is incorporated by this  
24 reference and which will adjust operational and/or personnel line items, but will  
25 not change the original budget amount of \$870,848.15; and

26 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2022 Sells District North  
27 Communities Multi-Year Budget Amendment No. 1 and recommends its  
28 approval.

29 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
30 **FY 2022 Sells District North Communities Multi-Year Budget Amendment No. 1**  
31 **effective October 1, 2021 through September 30, 2024, which does not change the**  
32 **FY 2022 Sells District North Communities Multi-Year Budget amount of**  
33 **\$870,848.15.**



1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2022 Sells  
2 **District North Communities Multi-Year Budget as amended shall be managed**  
3 **and expended in accordance with Article IX, Section 7 of the Constitution of the**  
4 **Tohono O'odham Nation and the Nation's laws, provided that any amendments or**  
5 **modifications shall be authorized under District Council resolution and**  
6 **submitted for prior approval by the Tohono O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
8 **day of APRIL, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**  
9 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**  
10 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
11 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
12 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
13 **(48 Stat.984).**




