

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Sells District Ge Oidag Community Mining Royalties Budget)**

RESOLUTION NO. 23-119

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to
4 budgets authorized under resolutions of the district council and
5 approved by the Tohono O'odham Council. The management of
6 these funds shall be only by a treasurer or other authorized officer
7 of the district council who has furnished a surety bond satisfactory
8 to the treasurer of the Tohono O'odham Nation, and all
9 expenditures of these funds shall be by checks signed by such
10 treasurer or other authorized officer and the chairman or vice
11 chairman of the district council.

13 **WHEREAS,** by Resolution No. 20-240, the Legislative Council authorized the distribution of
14 mining royalties making available district allocations subject to budgets
15 approved in accordance with Article VI, Section 1(d)(2) and Article IX, Section 7 of
16 the Nation's Constitution; and

17 **WHEREAS,** by Sells District Council Resolution No. SD-51-23, the Sells District has authorized
18 the FY 2023 Sells District Ge Oidag Community Mining Royalties Budget, which is
19 incorporated by this reference, in the amount of \$28,951.34; and

20 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 Sells District Ge
21 Oidag Community Mining Royalties Budget and recommends its approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
23 FY 2023 Sells District Ge Oidag Community Mining Royalties Budget effective
24 October 1, 2022 in the amount of \$28,951.34 that shall be funded by the Sells
25 District mining royalty funds.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2023 Sells
27 District Ge Oidag Community Mining Royalties Budget shall be managed and
28 expended in accordance with Article IX, Section 7 of the Constitution of the
29 Tohono O'odham Nation and the Nation's laws, provided that any amendments or
30 modifications shall be authorized under District Council resolution and
31 submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH day of APRIL, 2023 at a meeting at which a quorum was present with a vote of 3,218,0 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by, Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
