

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Chukut Kuk District Budget Amendment No. 1)**

RESOLUTION NO. 23-120

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 **No district council shall expend district funds except pursuant to**
4 **budgets authorized under resolutions of the district council and**
5 **approved by the Tohono O'odham Council. The management of**
6 **these funds shall be only by a treasurer or other authorized officer**
7 **of the district council who has furnished a surety bond satisfactory**
8 **to the treasurer of the Tohono O'odham Nation, and all**
9 **expenditures of these funds shall be by checks signed by such**
10 **treasurer or other authorized officer and the chairman or vice**
11 **chairman of the district council.**

13 **WHEREAS,** the FY 2023 Chukut Kuk District Budget in the amount of \$2,504,558.98 was
14 authorized by Chukut Kuk District Council Resolution No. 2022-31 and approved
15 by Legislative Council Resolution No. 22-354; and

16 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2023-11, the Chukut Kuk District
17 has authorized and submitted for review and approval its FY 2023 Chukut Kuk
18 District Budget Amendment No. 1, which includes the FY 2023 Chukut Kuk District
19 West Villages Community Budget Amendment No. 1, authorized by Chukut Kuk
20 District Council Resolution No. 2023-06, and the FY 2023 Chukut Kuk District
21 Tecolote Community Budget Amendment No. 1, authorized by Chukut Kuk
22 District Council Resolution No. 2023-10 (collectively, the "FY 2023 Chukut Kuk
23 District Budget Amendment No. 1"); and

24 **WHEREAS,** the FY 2023 Chukut Kuk District Budget Amendment No. 1 is incorporated by this
25 reference and will adjust operational and/or personnel line items; and

26 **WHEREAS,** the FY 2023 Chukut Kuk District West Villages Community Budget Amendment
27 No. 1 will increase the FY 2023 Chukut Kuk District West Villages Community
28 Budget by \$29,041.96 from \$40,000.00 to \$69,041.96; and

29 **WHEREAS,** the FY 2023 Chukut Kuk District Tecolote Community Budget Amendment No. 1
30 will increase the FY 2023 Chukut Kuk District Tecolote Community Budget by
31 \$130,166.99 from \$40,000.00 to \$170,166.99; and

1 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2023 Chukut Kuk District**
2 **Budget Amendment No. 1 and recommends its approval.**

3 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
4 **FY 2023 Chukut Kuk District Budget Amendment No. 1 effective October 1, 2022,**
5 **which includes:**

6 **1. the FY 2023 Chukut Kuk District West Villages Community Budget**
7 **Amendment No. 1, which includes a \$29,041.96 increase from \$40,000.00 to**
8 **\$69,041.96, and shall be funded by Chukut Kuk District West Villages**
9 **Community Budget carryover balances as follows:**

- 10 • **FY 2020 gaming carryover funds in the amount of \$2,744.72;**
- 11 • **FY 2021 gaming carryover funds in the amount of \$9,706.73;**
- 12 • **FY 2022 gaming carryover funds in the amount of \$11,677.92;**
- 13 • **FY 2014 mining carryover funds in the amount of \$2,258.44; and**
- 14 • **FY 2016 mining carryover funds in the amount of \$2,654.15.**

15 **2. the FY 2023 Chukut Kuk District Tecolote Community Budget Amendment**
16 **No. 1, which includes a \$130,166.99 increase from \$40,000.00 to**
17 **\$170,166.99, and shall be funded by Chukut Kuk District Tecolote**
18 **Community Budget carryover balances as follows:**

- 19 • **FY 2015 gaming carryover funds in the amount of \$17,785.09;**
- 20 • **FY 2020 gaming carryover funds in the amount of \$27,802.35;**
- 21 • **FY 2021 gaming carryover funds in the amount of \$72,612.11;**
- 22 • **FY 2022 gaming carryover funds in the amount of \$500.00; and**
- 23 • **FY 2016 mining carryover funds in the amount of \$11,467.44.**

24 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the FY 2023 Chukut**
25 **Kuk District Budget Amendment No. 1 will increase the overall FY 2023 Chukut**
26 **Kuk District Budget by \$159,208.95 from \$2,504,558.98 to \$2,663,767.93.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2023 Chukut**
28 **Kuk District Budget as amended shall be managed and expended in accordance**
29 **with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and**
30 **the Nation's laws, provided that any amendments or modifications shall be**
31 **authorized by Chukut Kuk District Council Resolution and submitted for prior**
32 **approval by the Tohono O'odham Legislative Council.**


