

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2021–FY 2025 Chukut Kuk District American Rescue Plan Act Budget)

RESOLUTION NO. 23-121

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only**
6 **by a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS,** by Chukut Kuk District Council Resolution No. 2023-12, the Chukut Kuk District
13 has authorized the FY 2021–FY 2025 Chukut Kuk District American Rescue Plan
14 Act Budget, which is incorporated by this reference, in the amount of
15 \$4,507,948.00; and

16 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2021–FY 2025 Chukut Kuk
17 District American Rescue Plan Act Budget and recommends its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2021–FY 2025 Chukut Kuk District American Rescue Plan Act Budget effective
20 March 11, 2021 in the amount of \$4,507,948.00, which shall be funded by the
21 Tohono O'odham Nation American Rescue Plan Act funds pursuant to Resolution
22 No. 21-292.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2021–FY 2025
24 Chukut Kuk District American Rescue Plan Act Budget shall be managed and
25 expended in accordance with Article IX, Section 7 of the Constitution of the
26 Tohono O'odham Nation and the Nation's laws, provided that any amendments or
27 modifications shall be authorized under District Council resolution and
28 submitted for prior approval by the Tohono O'odham Legislative Council.

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
30 **day of APRIL, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
31 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**
32 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
33 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
34 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
35 **(48 Stat.984).**
