

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 Baboquivari District South Komelic Community Budget
Amendment No. 1)**

RESOLUTION NO. 23-125

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS,** the FY 2023 Baboquivari District Administration and Community Budgets in the
13 amount of \$3,932,391.66 were authorized by Baboquivari District Resolution No.
14 2022-B-73 and approved by Legislative Council Resolution No. 22-353, and
15 subsequently amended by Resolution No. 22-395, increasing the FY 2023
16 Baboquivari District Administration and Community Budgets by \$1,160,661.30
17 from \$3,932,391.66 to \$5,093,052.96, and Resolution No. 23-037; and

18 **WHEREAS,** by Baboquivari District Resolution No. 2023-B-17, the Baboquivari District
19 Council has authorized and submitted for review and approval its FY 2023
20 Baboquivari District South Komelic Community Budget Amendment No. 1, which
21 is incorporated by this reference and which will adjust operational and/or
22 personnel line items; and

23 **WHEREAS,** the FY 2023 Baboquivari District South Komelic Community Budget Amendment
24 No. 1 will not change the FY 2023 South Komelic Community Budget amount of
25 \$457,612.39; and

26 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2023 Baboquivari District
27 South Komelic Community Budget Amendment No. 1 and recommends its
28 approval.

29 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
30 **FY 2023 Baboquivari District South Komelic Community Budget Amendment No.**
31 **1 effective October 1, 2022, which will not change the FY 2023 South Komelic**
32 **Community Budget amount of \$457,612.39 nor the FY 2023 Baboquivari District**
33 **Administration and Community Budgets amount of \$5,093,052.96.**



2 **Baboquivari District Budget as amended shall be managed and expended in**
3 **accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham**
4 **Nation and the Nation's laws, provided that any amendments or modifications**
5 **shall be authorized under District Council resolution and submitted for prior**
6 **approval by the Tohono O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
8 **day of APRIL, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**
9 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by,**
10 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
11 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
12 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
13 **(48 Stat.984).**




