The management of these funds shall be only by 6 a treasurer or other authorized officer of the district council who has 7 furnished a surety bond satisfactory to the treasurer of the Tohono O'odham 8 Nation, and all expenditures of these funds shall be by checks signed by such 9 treasurer or other authorized officer and the chairman or vice chairman of 10 the district council. 11 ; and 12 by Baboquivari District Council Resolution No. 2022-B-95, the Baboquivari WHEREAS, 13 District has authorized the FY 2021-2024 American Rescue Plan Act Budget, which 14 is incorporated by this reference, in the amount of \$4,986,181.00; and 15 WHEREAS, the Budget and Finance Committee has reviewed the FY 2021-2024 Baboquivari 16 District American Rescue Plan Act Budget and recommends its approval. 17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the 18 FY 2021-2024 Baboquivari District American Rescue Plan Act Budget in the 19 amount of \$4,986,181.00 effective March 11, 2021 through December 31, 2024, 20 which shall be funded by the Tohono O'odham Nation American Rescue Plan Act 21 funds pursuant to Resolution No. 21-292. 22 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2021-2024 23 Baboquivari District American Rescue Plan Act Budget shall be managed and 24 expended in accordance with Article IX, Section 7 of the Constitution of the 25 Tohono O'odham Nation and the Nation's laws, provided that any amendments or 26 modifications shall be authorized under District Council resolution and 27 submitted for prior approval by the Tohono O'odham Legislative Council. 28 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13^{11} 29 day of APRIL, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; <u>-0-</u> 30 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by, 31 Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono

O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -

Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
