

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2023-FY 2024 Planning and Economic Development Department,  
Roads Program Santa Rosa Ranch Road PIR 35(2) Budget)**

**RESOLUTION NO. 23-131**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Planning and Economic Development Department, Roads Program has  
8 prepared and submitted for review and approval its FY 2023-FY 2024 Santa Rosa  
9 Ranch Road PIR 35(2) Budget, which is incorporated by this reference, in the  
10 amount of \$700,000.00 to be funded by the Nation's general fund pending  
11 reimbursement from the grantor, the U.S. Bureau of Indian Affairs ("BIA"); and

12 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees  
13 have reviewed the FY 2023-FY 2024 Planning and Economic Development  
14 Department, Roads Program Santa Rosa Ranch Road PIR 35(2) budget and  
15 recommend its approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
17 **FY 2023-FY 2024 Planning and Economic Development Department, Roads**  
18 **Program, Santa Rosa Ranch Road PIR 35(2), effective December 21, 2022 through**  
19 **September 30, 2024 in amount of \$700,000.00, which shall be funded by the**  
20 **Nation's general fund pending reimbursement for the grantor, the U.S. Bureau of**  
21 **Indian Affairs ("BIA").**

22 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
23 **Nation chairperson or any designated official is authorized to administer and**  
24 **expend these funds for the period of December 21, 2022 through September 30,**  
25 **2024, and the Accounting Department is authorized to post the unexpended**  
26 **balance of the budget, provided that any amendments or modifications shall be**  
27 **submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>**  
29 **day of APRIL, 2023 at a meeting at which a quorum was present with a vote of 3,218.0 FOR; -0-**  
30 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by,**  
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
34 **18, 1934 (48 Stat.984).**
