13		approved a second time for membership by Resolution No. 08-330; and
14	WHEREAS,	the Enrollment Committee recommends that Resolution No. 08-330 be amended
15		to delete the member identified in the Amending Enrollment Resolution List for
16		May 2023, which is incorporated by this reference; and
17	WHEREAS,	the member who was originally approved in Resolution No. 07-657 will retain the
18		roll number and approval date identified in that resolution.
