5		duties and powers of committees, boards, officers and agents" (Constitution of
6		the Tohono O'odham Nation, Article VI, Section 1(b) and Section 1(c)(2)); and
7	WHEREAS,	the Legislative Council is further vested with the authority to "consult, negotiate
8		and conclude agreements and contracts on behalf of the Tohono O'odham Nation
9		with Federal, State and local governments on all matters within the authority
10		of the Tohono O'odham Council" (Constitution of the Tohono O'odham Nation,
11		Article VI, Section 1(f)); and
12	WHEREAS,	the Central Arizona Water Conservation District ("CAWCD") is a multi-county
13		water district spanning Maricopa, Pima, and Pinal counties that is responsible
14		for operating and maintaining the Central Arizona Project and its Board of
15	,	Directors consists of a 15-member board of directors elected from the three-
16		county service area made up of Maricopa, Pima, and Pinal counties; and
17	WHEREAS,	the Governor of Arizona Katie Hobbs has selected Justin Manuel, Assistant
18		Director, Water Resources Department to fill a vacancy on the CAWCD Board of
19		Directors pursuant to Arizona Revised Statutes § 48-3708; and
20	WHEREAS,	Chairman Ned Norris, Jr. and the Water Resources Committee recommend
21		supporting the appointment of Justin Manuel to the Central Arizona Water
22		Conservation District Board of Directors.
