

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2023 - FY 2025 Department of Health and Human Services Family
Violence Prevention Service Administration Grant—American Rescue Plan Budget)

RESOLUTION NO. 23-150

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d) (2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2023 – FY 2025 Family Violence Prevention Service
9 Administration Grant-American Rescue Plan Budget, which is incorporated by
10 this reference, in the amount of \$259,279.86 to be funded by the Nation's general
11 fund pending reimbursement from the grantor, the U.S. Department of Health
12 and Human Services; and

13 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
14 reviewed the FY 2023 – FY 2025 Department of Health and Human Services Family
15 Violence Prevention Service Administration Grant-American Rescue Plan Budget
16 and recommend its approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 FY 2023 – FY 2025 Department of Health and Human Services Family Violence
19 Prevention Service Administration Grant-American Rescue Plan Budget effective
20 October 1, 2022 through September 30, 2025 in the amount of \$259,279.86, which
21 shall be funded by the Nation's general fund pending reimbursement from the
22 grantor, the U.S. Department of Health and Human Services.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 Nation chairperson or any designated official is authorized to administer
25 and expend these funds for the period of October 1, 2022 through September 30,
26 2025, and the Accounting Department is authorized to post the unexpended
27 balance of the budget, provided that any amendments or modifications shall be
28 submitted for prior approval by the Tohono O'odham Legislative Council.
