

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024 Department of Health and Human Services Self-Governance Budgets)**

**RESOLUTION NO. 23-161**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
 2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
 3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
 4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
 5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
 6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
 8 **review and approval its FY 2024 Self-Governance Budgets, for the period**  
 9 **beginning October 1, 2023 and ending on September 30, 2024 (collectively "FY**  
 10 **2024 Department of Health and Human Services Self-Governance Budgets"),**  
 11 **which are provided below and incorporated by this references, in the total**  
 12 **amount of \$7,360,768.70 to be funded by the Self-Governance Funding**  
 13 **Agreement; and**

14 **WHEREAS, the following base budgets in the amount of \$6,931,514.28 have been prepared as**  
 15 **follows:**


1 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
2 **FY 2024 Department of Health and Human Services Self-Governance Budgets**  
3 **effective October 1, 2023 in amount of \$7,360,768.70, which shall be funded by the**  
4 **Self-Governance Funding Agreement.**

5 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the Tohono  
6 **O'odham Nation Chairperson or any designated official is authorized to negotiate**  
7 **and execute amendments to the Self-Governance Funding Agreement with the**  
8 **Indian Health Service for the maximum allowable funding.**

9 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
10 **Nation chairperson or any designated official is authorized to administer and**  
11 **expend the FY 2024 Department of Health and Human Services Self-Governance**  
12 **Budgets, provided that any amendments or modifications shall be submitted for**  
13 **prior approval by the Tohono O'odham Legislative Council.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup>**  
15 **day of MAY, 2023 at a meeting at which a quorum was present with a vote of 2,947.3 FOR; -0-**  
16 **AGAINST; -0- NOT VOTING; and 270.7[04] ABSENT, pursuant to the powers vested in the Council**  
17 **by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**  
18 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
19 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
20 **Act of June 18, 1934 (48 Stat.984).**
