

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Hewel Ni'ok KOHN Corporation for Public Broadcasting
Community Service Grant Restricted Budget)**

RESOLUTION NO. 23-165

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Hewel Ni'ok has prepared and submitted for review and approval its FY 2024
8 KOHN Corporation for Public Broadcasting Community Service Grant Restricted
9 Budget, which is incorporated by this reference, in the amount of \$49,634.63 to be
10 funded from the Nation's general fund pending reimbursement by the grantor,
11 the Corporation for Public Broadcasting; and

12 **WHEREAS,** the Cultural Preservation and Budget and Finance Committees have reviewed the
13 FY 2024 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
14 Service Grant Restricted Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
16 FY 2024 Hewel Ni'ok KOHN Corporation for Public Broadcasting Community
17 Service Grant Restricted Budget effective October 1, 2023 in amount of \$49,634.63
18 which shall be funded by the Nation's General Fund pending reimbursement by
19 the grantor, the Corporation for Public Broadcasting.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
21 Nation chairperson or any designated official is authorized to administer and
22 expend the FY 2024 Hewel Ni'ok KOHN Corporation for Public Broadcasting
23 Community Service Grant Restricted Budget, provided that any amendments or
24 modifications shall be submitted for prior approval by the Tohono O'odham
25 Legislative Council.

26 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 23RD
27 day of MAY, 2023 at a meeting at which a quorum was present with a vote of 2,947.3 FOR;
28 -0- AGAINST; -0- NOT VOTING; and 270.7[05] ABSENT, pursuant to the powers vested in the
29 Council by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,
30 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
31 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
32 Act of June 18, 1934 (48 Stat.984).
