

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Water Resources Department Southern Arizona Water
Rights Settlement Act Budget)**

RESOLUTION NO. 23-175

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Water Resources Department has prepared and submitted for review and**
8 **approval its FY 2024 Southern Arizona Water Rights Settlement Act ("SAWRSA")**
9 **Budget, which is incorporated by this reference, in the amount of \$2,091,243.54 to**
10 **be funded by the SAWRSA Trust Fund; and**

11 **WHEREAS, the Water Resources and Budget and Finance Committees have reviewed the FY**
12 **2024 Water Resources Department SAWRSA Budget and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **FY 2024 Water Resources Department SAWRSA Budget effective October 1, 2023 in**
15 **amount of \$2,091,243.54, which shall be funded by the SAWRSA Trust Fund.**

16 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
17 **Nation chairperson or any designated official is authorized to administer and**
18 **expend the FY 2024 Water Resources Department SAWRSA Budget, provided that**
19 **any amendments or modifications shall be submitted for prior approval by the**
20 **Tohono O'odham Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH**
22 **day of MAY, 2023 at a meeting at which a quorum was present with a vote of 2,947.3 FOR;**
23 **-0- AGAINST; -0- NOT VOTING; and 270.7 [06] ABSENT, pursuant to the powers vested in the**
24 **Council by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
25 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
26 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
27 **Act of June 18, 1934 (48 Stat.984).**


