

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Water Resources Department Environmental Protection
Agency Budget)**

RESOLUTION NO. 23-176

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Water Resources Department has prepared and submitted for review and**
8 **approval its FY 2024 Environmental Protection Agency ("EPA") Budget, which is**
9 **incorporated by this reference, in the amount of \$135,000.00 to be funded by the**
10 **Nation's general fund pending reimbursement from the grantor, the U.S.**
11 **Environmental Protection Agency; and**

12 **WHEREAS, the Water Resources and Budget and Finance Committees have reviewed the FY**
13 **2024 Water Resources Department EPA Budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2024 Water Resources Department EPA Budget effective October 1, 2023 in**
16 **amount of \$135,000.00, which shall be funded by the Nation's general fund**
17 **pending reimbursement from grantor, the U.S. Environmental Protection**
18 **Agency.**

19 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the**
20 **Nation's chairperson or any designated official to seek reimbursement for**
21 **indirect cost expenses in the event an indirect cost rate is approved.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2024 Water Resources Department Environmental Protection**
25 **Agency Budget, provided that any amendments or modifications shall be**
26 **submitted for prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH**
28 **day of MAY, 2023 at a meeting at which a quorum was present with a vote of 2,947.3 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and 270.7 [06] ABSENT, pursuant to the powers vested in the**
30 **Council by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
31 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
32 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
33 **Act of June 18, 1934 (48 Stat.984).**


