

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Public Safety Tribal Employment Rights
Office Equal Employment Opportunity Commission Budget)**

RESOLUTION NO. 23-178

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Public Safety has prepared and submitted for review and
8 approval its FY 2024 Tribal Employment Rights Office ("TERO") Equal
9 Employment Opportunity Commission ("EEOC") Budget, which is incorporated by
10 this reference, in the amount of \$30,000.00 to be funded from the Nation's general
11 fund pending reimbursement from the EEOC; and

12 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have
13 reviewed the FY 2024 Department of Public Safety TERO EEOC Budget and
14 recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
16 FY 2024 Department of Public Safety TERO EEOC Budget effective October 1, 2023
17 in the amount of \$30,000.00, which shall be funded by the Nation's general fund
18 pending reimbursement by the EEOC.

19 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
20 Nation chairperson or any designated official is authorized to administer and
21 expend the FY 2024 Department of Public Safety TERO EEOC Budget, provided that
22 any amendments or modifications shall be submitted for prior approval by the
23 Tohono O'odham Legislative Council.

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH**
25 **day of MAY, 2023 at a meeting at which a quorum was present with a vote of 2,947.3 FOR;**
26 **~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and 270.7 [06] ABSENT, pursuant to the powers vested in the**
27 **Council by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
28 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
30 **Act of June 18, 1934 (48 Stat.984).**
