

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Public Safety Environmental Protection
Office General Assistance Program Project Budget)**

RESOLUTION NO. 23-179

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Public Safety has prepared and submitted for review and**
8 **approval its FY 2024 Environmental Protection Office General Assistance**
9 **Program Project Budget, which is incorporated by this reference, in the amount**
10 **of \$625,459.47 to be funded by the Nation's general fund pending reimbursement**
11 **from the grantor, Indian General Assistance Program of the U.S. Environmental**
12 **Protection Agency; and**

13 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
14 **2024 Department of Public Safety Environmental Protection Office General**
15 **Assistance Program Project Budget and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2024 Department of Public Safety Environmental Protection Office General**
18 **Assistance Program Project Budget effective October 1, 2023 in amount of**
19 **\$625,459.47, which shall be funded by the Nation's general fund pending**
20 **reimbursement from the grantor, Indian General Assistance Program of the U.S.**
21 **Environmental Protection Agency.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2024 Department of Public Safety Environmental Protection Office**
25 **General Assistance Program Project Budget, provided that any amendments or**
26 **modifications shall be submitted for prior approval by the Tohono O'odham**
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH**
29 **day of MAX, 2023 at a meeting at which a quorum was present with a vote of 2,947.3 FOR;**
30 **-0- AGAINST; -0- NOT VOTING; and 270.7 [06] ABSENT, pursuant to the powers vested in the**
31 **Council by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
32 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
33 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
34 **Act of June 18, 1934 (48 Stat.984).**
