

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2024 Department of Health and Human Services Division of
Health Transportation Service Program Revenue Funding Budget)**

RESOLUTION NO. 23-181

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
8 **review and approval its FY 2024 Division of Health Transportation Service**
9 **Program Revenue Funding Budget, which is incorporated by this reference, in the**
10 **amount of \$3,987,363.45 of which \$3,223,363.45 to be funded from the Nation's**
11 **General Fund; and \$620,000.00 is funded program revenues and \$144,000.00 is**
12 **funded from miscellaneous revenues; and**

13 **WHEREAS, the portion of the FY 2024 Department of Health and Human Services Division of**
14 **Health Transportation Service Budget to be funded from the Nation's general**
15 **fund is addressed by separate resolution; and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
17 **reviewed the FY 2024 Department of Health and Human Services Division of**
18 **Health Transportation Service Program Revenue Funding Budget and**
19 **recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2024 Department of Health and Human Services Division of Health**
22 **Transportation Service Program Revenue Funding Budget effective October 1,**
23 **2023 in the amount of \$3,987,363.45 of which \$3,223,363.45 to be funded from the**
24 **Nation's General Fund \$620,000.00 which shall be funded by Health**
25 **Transportation Service program revenues and \$144,000.00 which shall be funded**
26 **by miscellaneous revenues**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Nation chairperson or any designated official is authorized to administer and**
29 **expend the FY 2024 Department of Health and Human Services Division of Health**
30 **Transportation Service Program Revenue Funding Budget, provided that any**
31 **amendments or modifications shall be submitted for prior approval by the**
32 **Tohono O'odham Legislative Council.**




