10		Nation's general fund pending reimbursement from the grantor, the State of
11		Arizona; and
12	WHEREAS,	the Health and Human Services and Budget and Finance Committees have
13		reviewed the FY 2024 Department of Health and Human Services Arizona Long
14		Term Care Systems Budget and recommend its approval.
15	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
16		FY 2024 Department of Health and Human Services Arizona Long Term Care
17		Systems Budget effective October 1, 2023 in the amount of \$423,133.77, which
18		shall be funded by the Nation's general fund pending reimbursement from the
19		grantor, the State of Arizona.
