

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2024 Tohono O'odham Nation Health Care Budgets)**

**RESOLUTION NO. 23-191**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Health Care have prepared and submitted for review**  
8 **and approval its FY 2024 Tohono O'odham Nation Health Care Budgets**  
9 **(collectively, "FY 2024 Tohono O'odham Nation Health Care Budgets") and as**  
10 **identified in FY 2024 Tohono O'odham Nation Health Care Budgets Schedule,**  
11 **which is attached and incorporated by this reference, in the total amount of**  
12 **\$143,752,787.99; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
18 **reviewed the FY 2024 Tohono O'odham Nation Health Care Budgets and**  
19 **recommend their approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2024 Tohono O'odham Nation Health Care Budgets effective October 1, 2023 in**  
22 **the total amount of \$143,752,787.99, which shall be funded by the Indian Health**  
23 **Service and third party revenues.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Nation chairperson or any designated official is authorized to administer and**  
26 **expend the FY 2024 Tohono O'odham Nation Health Care Budgets, provided that**  
27 **the Governing Body shall approve any amendments or modifications, subject to**  
28 **final approval by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup>**  
30 **day of MAY, 2023 at a meeting at which a quorum was present with a vote of 2,947.3 FOR;**  
31 **-0- AGAINST; -0- NOT VOTING; and 270.7 [07] ABSENT, pursuant to the powers vested in the**  
32 **Council by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**  
33 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
34 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
35 **Act of June 18, 1934 (48 Stat.984).**
