

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2024 Department of Health and Human Services**  
**Division of Behavioral Health First Things First Budget)**

**RESOLUTION NO. 23-195**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
8 review and approval its FY 2024 Division of Behavioral Health First Things First  
9 Budget, which is incorporated by this reference, in the amount of \$100,000.00, to  
10 be funded by the Nation's general fund, pending reimbursement from the  
11 grantor, the Arizona Early Childhood Development and Health Board; and

12 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
13 reviewed the FY 2024 Department of Health and Human Services Division of  
14 Behavioral Health First Things First Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
16 FY 2024 Department of Health and Human Services Division of Behavioral Health  
17 First Things First Budget, effective July 1, 2023 in the amount of \$100,000.00,  
18 which shall be funded by the Nation's general fund pending reimbursement from  
19 the grantor, the Arizona Early Childhood Development and Health Board.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
21 Nation chairperson or any designated official is authorized to administer and  
22 expend the FY 2024 Department of Health and Human Services Division of  
23 Behavioral Health First Things First Budget, provided that any amendments or  
24 modifications shall be submitted for prior approval by the Tohono O'odham  
25 Legislative Council.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25<sup>TH</sup>**  
27 **day of MAY, 2023** at a meeting at which a quorum was present with a vote of 2,947.3 **FOR;**  
28 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and 270.7 [05] ABSENT,** pursuant to the powers vested in the  
29 **Council by, Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**  
30 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
31 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
32 **Act of June 18, 1934 (48 Stat.984).**
